## **St. Peter Chanel High School Open House**

**Sun., Nov 11: Open House** Noon to 3:00p - For Future Students! Want to learn more about Chanel? Join us for our last fall Open House. All parents and students welcome. Take a tour. Ask questions. Learn about scholarship opportunities! Chanel offers courses that earn college credit without leaving our campus! St. Peter Chanel High School is in partnership with Cuyahoga Community College offering the Post Secondary Enrollment Option Program (PSEOP) and a Dual Credit Program. Students who attend St. Peter Chanel will be able to earn college credit while taking courses at Chanel, without having to leave the Chanel campus. The Tri-C courses being offered at Chanel include U.S. History, Composition & Grammar, with more offerings being considered for the future. These courses are included in the core curriculum of most major colleges.

The credits earned in these programs are transferable to any college in the country that accepts credits from Tri-C. "We are very excited to offer these programs to our families at no cost above the Chanel tuition," states Roger Abood, President of St. Peter Chanel High School, "one-third of our current juniors are enrolled in an Advanced Placement class or the PSEOP program! We are very proud of the exceptional academic ability of our students and are glad we can provide this opportunity for them."

A student who takes part in this program and passes the courses could earn up to twenty-four college credit hours. This could provide an estimated savings of \$3,300 to \$17,500 in college costs. With PSEOP, there is no cost to parents. Those in the Dual Credit Program pay tuition to Tri-C and reimbursed by Chanel. Any cost associated with this

program is included in tuition paid to St. PeterChanel High School.

Each student must pass an entrance test administered by Tri-C to be admitted into the various courses. St. Peter Chanel is extremely excited about the opportunity to offer this unique program to our students. Chanel students now have the opportunity to take multiple courses and receive both high school and college credit.
